



1. SELECTION AND ADMISSION OF THE CANDIDATE PARTICIPANTS

A commission composed by the authorities of the Veterinary School and the teachers <u>will select the 2</u> <u>participants for each intake</u>. The selection will be based on the contents of the demanded documents. Incomplete demands due to missing documents will not be taken in consideration for selection. Candidates will be informed about their admission 4 months before the start of the course.

2. MANDATORY DOCUMENTS.

- 1. Copy of you ID
- 2. Copy highest obtained diploma or certificate with mention of the obtained grade
- 3. Curriculum Vitae (no longer than 1 page)
- 4. Accompanying letter
- 5. Completed and signed registration form
- 6. Signed confidentiality agreement.
- 7. Certificate of good standing issued by your government (criminal record) not older than 1 month at the time of submission.

Authentication of documents, copies or autographs is mandatory for translated documents. Documents in French, German, Italian, Dutch and English do not need to be translated.

3. COSTS & FEES

The cost of the course is 4860 Euro for the full week. This price includes:

- 1. Practical and theoretical courses
- 2. Accommodation, no reduction if the participant is taking care himself of the accommodation
- 3. Course biological material
- 4. Course disposables
- 5. Course booklet
- 6. Breakfast and lunches for the time of the course
- 7. Transport of between hotel and course location
- 8. Free visit to a modern IVF-lab
- 9. Free access to all Quartec Internet Seminars for 12 months

4. **DEPOSIT**

A deposit of 500 CHF Cash or equivalent, will be demanded at the start of the course to cover eventual damage to the equipment during the course. This amount will be fully reimbursed at the end of the course if the used instruments were not damaged.





5. PAYMENTS

The full amount must be paid by a single bank transfer within 30 days after the emission date of the invoice mailed by the central financial department of the university. Bank costs are at the charge of the participant. If the payment is not on

6. CANCELLATION

If the organizers are obliged to cancel the course, then the total amount of 4500 Euro will be reimbursed to the participant. Bank costs are at charge of Quartec GmbH.

Cancellations by the admitted participant are reimbursed as follows

- 1. 4000 Euro if cancelled before 3 months from the starting date of the session
- 2. 3000 Euros if cancelled between 2 and 3 months before the starting date of the session
- 3. No reimbursement if cancelled later than 2 months before the starting date of the session

AgroVet-Strickhof is a cooperation between the ETH Zurich, The University of Zurich and Strickhof, the competence centre for education and services in agriculture, animal nutrition and reproduction of the Kanton of Zurich.

9. TRANSPORT

The costs for public transport between the airport and the hotel at arrival and departure are included in the course fee. As far as possible we will do our best to pick you up at the Zürich Airport.

Costs for car parking are at charge of the participant if you use your own car.

Swiss public transport is excellent we recommend leaving your car behind to avoid traffic jams.

Your transport from the Hotel to ITCART/AGROVET is covered by the course fee you will receive a public transport card for the duration of the course.

From the Zürich Airport to Effretikon:

Train S24 direction Weinfelden or Thayngen, will take you in 10 minutes to Effritikon, the second stop.





From Hotel Rubus to Agrovet:

BUS 650 Direction "Kempttal-Bahnhof" from stop "Zentrum" in Effretikon, a 4 minutes walk from Hotel Rubus.

10. INSURANCE

The organizers are not responsible for accidents which may happen during the course or on the waybetween the place of temporary residence and the course venue. It is up to the participants to subscribe the requested, travel and medical health insurances at their own costs.

11. SECURITY, HYGIENE, SAFETY

Switzerland is a safe country, pay attention for pickpockets in airports, train station and on public transport.

Smoking, eating and drinking in the laboratory area is strictly forbidden. The use and application of perfumes and cosmetics in the laboratory facilities is not allowed.

The use of cellular phones is not allowed within the course facilities.

Protective cloths, protective glasses s and gloves have to be used were recommended.

In case of emergency evacuation follow the instructions given by the authorities.

Participants who do not respect the regulation may be dismissed immediately from the course without any type of reimbursement.

Photographs or videos of persons, equipment, installations is subject to permissions.

12. CONFIDENTIALITY AGREEMENT

All participants must sign a confidentiality agreement to ensure that no personal, economical, technical or scientific information is rendered without the agreement of both parties. ITCART will not communicate directly with your actual or future employers.

A passport valid for three months beyond the length of stay (or for the duration of stay for EU/EEA nationals) and issued within the past 10 years is required by all nationals referred to in the chart above, except (1) EU nationals holding a valid national identity card.

Regulations also apply to Liechtenstein (no border control between the two countries).

Passengers arriving at Basel or Geneva airports can enter either France or Switzerland, provided their documents for the country of entry are in order; both airports have two different exits, one to France and one to Switzerland. Therefore passengers can exit to the French part of the airport with a valid French or Schengen visa, if required.

The airport of Basel/Mulhouse is located on French territory.

Part of Geneva airport is located by convention in France and some flights between France and Geneva are considered as domestic flights while others are considered international flights. In this case, passengers must hold proper entry documents for either of the destination countries.

The nearest airport is Zürich. We can only pick you up from this airport as far as possible.

Visas:

Visas are not required by all nationals referred to in the chart above for stays in Switzerland of up to three months.

Nationals not referred to in the chart are advised to contact the embassy to check visa requirements for Switzerland.

The organizers of the course to not provide any service in relation to passport and visa demands except providing course admission confirmation and hotel reservation confirmation.

Validity:

Schengen visa: 90 days within a six-month period.

Schengen visas:

Switzerland is part of the Schengen area.





Temporary residence:

EU/EEA residents planning on staying in Switzerland for more than three months to work <u>must register with</u> the local authorities and apply for a residence permit. The length of the permit depends on the duration of the work. Slightly different rules apply to nationals of Bulgaria and Romania. Contact the State Secretariat for Migration (www.bfm.admin.ch) for details.

Working days:

Introduce your visa demand enough time in advance. Be aware that you will have to go for an interview. For some nationalities, it may take several weeks before you will receive an appointment.

Sufficient funds:

Schengen visa applicants must provide bank statements from the previous three months with their application.

Extension of stay:

Schengen visa holders can only extend their stay in exceptional circumstances, such as *force majeure*, or for humanitarian reasons.

14. CLIMAT

Switzerland is located within a temperate climatic zone. In the west and northwest the influence of the temperate Atlantic climate is felt more strongly, in the east the influence of the continental climate. At latitude of 47 degrees north, the climate is moderate and generally agreeable. Temperatures depend largely on altitude, with averages 5°C lower for each additional 300 m of elevation. Summers can be hot, with temperatures sometimes reaching 30°C or more, summer evenings are usually cool.

Precipitation is distributed over the entire year. May, September and the first half of October tend to be the driest, April and November are usually the wettest periods. Again, High-level areas in the Alps may have a high average rainfall in excess of 2000 mm per year, while some regions in the flatlands of Switzerland have only 600 mm per year. From June through August, rain usually comes in the form of sometimes heavy thunderstorms; these storms can sometimes bring heavy hail and snowfall in the mountainous regions of the Alps, even in summer.

Weather conditions vary only slightly across the country, the lowland regions in the north and east have more continental influenced conditions with colder winters and hotter summers, and the South-eastern areas of Switzerland have longer and warmer, almost Mediterranean-like summers. Be aware that whatever the season, if you're at a high altitude, the weather can change quickly and dramatically.

The winter snow cover lasts from late December through March in the valleys, from November through May at about 1,800 m, and becomes in many years permanent above about 2,500 m.

Required clothing:

Lightweights with rainwear for summer, waterproof Medium- to Heavyweights for winter. A sweater is necessary almost any time of year.
